INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

1. The Catarman Water District, through the "2016 National Government Subsidy, intends to apply the sum of P 1,039,498.42 being the Approved Budget for the Contract (ABC) as per Board Resolution No. 04 Series of 2019 dated March 16, 2019 to payments under the contract for the Drilling of One (1) Exploratory/Production Well. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Catarman Water District invites bids for the Drilling of One (1) Exploratory/Production Well. Completion of the Works is required within thirty-one (31) calendar days. The prospective Bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information and clarification from Catarman WD BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm weekdays.

A complete set of Bidding Documents may be purchased anytime during office hour by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of P 3,000.00. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
